## MAY IT PLEASE THE PANEL:

 This memorandum is filed on behalf of the Waikato and Waipā River Iwi<sup>1</sup> (River Iwi) in relation to the availability of certain of the River Iwi's expert witnesses.

## Joint Witness Statement Hearing – 18 July 2019

- In relation to the forthcoming Joint Witness Statement hearing on 18 July, representatives of the River Iwi have been communicating with Mr Rice regarding:
  - (a) Dr Olivier Ausseil's inability to attend the hearing in person (as he will be overseas on 18 July); and
  - (b) whether alternate video or teleconference facilities may be available to enable Dr Ausseil to participate in the hearing on 18 July and answer any questions from the Panel.
- Counsel understands from Mr Rice that the Panel is aware of Dr Ausseil's unavailability and the proposals being considered to facilitate Dr Ausseil's attendance.
- 4. Alternatively, should it not be possible for Dr Ausseil to remotely participate in the hearing on 18 July, Dr Ausseil is able to provide written answers to any questions from the Panel (and would restrict such answers to those specific questions consistent with the Panel's minute of 25 June 2019).
- 5. While counsel and Dr Ausseil are continuing to work with Mr Rice on options for the hearing on 18 July 2019, this memorandum formally records Dr Ausseil's unavailability and seeks leave for Dr Ausseil to attend the hearing by video or teleconference or, in the alternative, to answer any questions from the Panel in writing.

## Extension of time for rebuttal evidence of Mr Hamish Lowe
