Summary statement

1. I disagree with the Officers' recommendation that the term "ecosystem services" should not be defined in PPC1.

2. If the term "ecosystem services" were retained in PPC1, then I seek for the definition of this term that is included in the Waikato Regional Policy Statement (RPS) to be included in PPC1.

 - (1) Qualifications and experience;
 - (2) Endorsement of the content of HCC's submissions and further submissions, except where stated otherwise in my evidence;
 - (3) Agreement to comply with the Code of Conduct for Expert Witnesses in the Environment Court Practice Note 2014; and
 - (4) Reserved position with respect to the relief my Block 1 evidence seeks.
- 4. As for my Block 1 evidence, I reserve my position with respect to the relief my Block 3 evidence seeks.

Relief sought

- 6. The relief I seek is identified in this evidence and collated in **Attachment B**, which also identifies the submission point relied upon.
- 7. The relief sought is shown as follows:

Scope of evidence

8. This evidence sets out my response to the Officers' recommendations about inclusion of a definition of "ecosystem services" in PPC1, a matter on which HCC made a submission.

Evidence

Additions to Glossary of Terms - "Ecosystem services"

- 9. HCC's submission seeks inclusion in PPC1 of the same definition of the term "ecosystem services" as is included in the RPS.
- 10. The term "ecosystem services" is used in the notified version of PPC1 in the following value statements:
 - Intrinsic values Ecosystem health (p.22);
 - Use values Mahinga kai (p.24); and
 - Use values Commercial, municipal and industrial use (p.25);
- 11. The term is not defined in PPC1 or the Operative Waikato Regional Plan, so there is a lack of clarity and certainty regarding what it, and the values in which the term is used, mean.
- 12. The s.42A Report states¹

Officers' consider that it is more appropriate for the above terms [which include "ecosystem services"] not to be defined, as they are generally used outside of the planning process, likely as part of broad assessments or in implementation by WRC. Officers are not convinced that a definition would add clarity or certainty to PC1.

- 13. I disagree. There needs to be a common, explicit understanding of all terms used in PPC1. It is inappropriate to allow WRC the discretion to decide for itself what any term in the plan means. Furthermore, to dismiss the need for a definition of the term on the basis that it is "...generally used outside of the planning process" is not an adequate justification to leave the term undefined.
- 14. On the basis that the term "ecosystem services" is retained in PPC1, I seek for the definition of "ecosystem services" that is in the RPS, to be included in PPC1, that is:

<u>Ecosystem services</u> – the benefits people obtain from ecosystems. These <u>include:</u>

- a) provisioning services (such as food and water);
- b) regulating services (such as flood and disease control);
- c) cultural services (such as spiritual, recreational, and cultural benefits); and
- d) supporting services (such as nutrient cycling);
- that maintain the conditions for life on Earth.
- 15. Inclusion of this definition in PPC1 would improve the plan's clarity and certainty and help achieve consistency across statutory documents.
