Finlayson Farms Ltd has a 200 Ha dairy unit. Approximately 140Ha lies within the TeKohanga Drainage District. There are several kilometres of drains that take spring flow and runoff from higher ground, to the drainage pumps. These drains are sprayed on an approximately 6 month cycle. This involves driving a tractor alongside the drains in order to apply herbicide in order to check the growth of weeds which will left unchecked hinder the flow of water to the pumps. These drains are cleaned on an approximately 3 year cycle. This involves a digger removing sediment and vegetation from the drain. This needs to be adjacent to the drain, as far as I know there is not a digger that can reach 3 metres and clean the bottom of the drain. Also the operator would not be able to see the drain level from this distance. There are several kilometres of a network of cow races on this drainage area. For historical reasons they are adjacent to these drains. It would be a massive financial and logistical imposition on the farm if a 3m setback was applied.	I seek that the whole of the submission be allowed A 0.5 metre fencing setback be uniformly applied in all setback situations in drainage districts.
