General comments

We farm just south of Tokoroa, South Waikato milking 440 cow on 140Ha (effective). We milk all year round operating a system 5 and milk in a 40-bail rotary shed.

We were involved in the Sustainable Milk Plan(SMP) project and over the past two years have continued to review the SMP, focussing on our achievements, reviewing our goals and objectives. The drop in the dairy pay-out delayed our new effluent management system, however that is currently underway.

Whilst we have had stock exclusion for over ten years on our farm, over the past two years we have reviewed our commitment to quality stream care with extra fencing and \$7,500 (2014/15) \$5,000 (2015/16) towards riparian and set back planting along our 1.2km boundary along the Matarawa Stream.

Our commitment through our farming business has always included a community, educational and social component, with strong involvement & commitment in Te Waihou Walkway and the Waikato River Trail Project as an example.

We have always farmed as best we are able, with a strong drive for breeding quality stock and farming for the best return with respect to the land and surrounding environment and believe in part this plan will protect what we already have.

We do believe:

- that many farmers do have the best intentions in their day to day operation and management and will have a positive attitude to working towards a better environment.
- that many farmers believe that all those contributing to contaminant discharges be required to take
 action along a similar path whether they are dairying, other agriculture, horticulture, forestry, industry
 or urban.
