I support the intention of using FEPs to manage a tailored approach to reducing diffuse discharges from farming practices.

I am concerned about the level of resource required by farmers and advisors to meet the FEP provisions in the current time frames. One professional having completed nutrient management training and with industry experience and working exclusively fulltime on FEPs will at best take three years to complete just the dairy farms in the Waipa catchment, allowing two working days per farm. Many farms will take longer.

Our property, farmed contiguously, is 33% dairy, 57% drystock and 10% cropping with 37% in Priority 1, and 63% in Priority 2, with four continuous flow water courses, wetland areas and slopes greater than 15 degrees. It is more than a two day FEP exercise.

I think timeframes should be modified to enable flexibility and allow the development of suitable, qualified and managed resources (advisors), and avoid a box ticking exercise that has inadequate audit procedures. Policy change should allow staged completion of FEPs to encourage participation and recognise that developing resource is a long term exercise i.e. a unit by unit approach rather than complete pass or fail on a given date.

I think FEPs produced by the farmer with managed industry support should be able to be produced on a farm by farm basis without applying one size fits all categories, and with the ability to take into account mitigating or burdensome factors - physical or financial.
