Jurisdiction and scope of submission

- 1. Auckland Regional Public Health Service (ARPHS) provides public health services for the three district health boards (DHBs) in the Auckland region (Counties Manukau Health and Auckland and Waitemata District Health Boards). As illustrated in Appendix B, part of this region extends into the Lower Waikato River catchment zone.
- Therefore, ARPHS's comments on the Proposed Waikato Regional Plan Change 1 Waikato and Waipa River Catchments (proposed plan change) relate to this designated area within the Lower Waikato River catchment zone.

Support for the proposed plan change

- For ARPHS contact recreation and drinking water source quality standards are two key concerns when considering how resources should be managed in the Lower Waikato River catchment zone.
- 4. ARPHS's main public health goals in relation to freshwater management are:
 - To minimise and prevent the risk of disease associated with the public use of recreational waters, and;
 - To optimise the safety and quality of all drinking water available for public consumption in the three DHB regions. In general, ARPHS considers smaller drinking water supplies (which generally have a lesser degree of treatment and monitoring) are at greater risk of being contaminated as a result of surrounding land use activities.
- 5. ARPHS notes the proposed plan change seeks to reduce key contaminants (nitrogen, phosphorus, sediment and microbial pathogens) entering water bodies in the Waipa and Waikato river catchments, with much of the emphasis on reducing contaminant losses from pastoral farm land, and better management of diffuse discharges to land and water. It sets out an 80 year timeframe for these entire river catchments and their tributaries to be swimmable and safe for food collection along their entire lengths.
- 6. Accordingly, ARPHS supports the overall intent of the proposed plan change to maintain and improve the overall quality of freshwater resources in the Waikato and Waipa river catchments. ARPHS considers effective implementation and compliance of the proposed provisions will be the key driver for water quality improvement in the region.
- In particular, ARPHS supports the following principles and methods established by the proposed plan change:

- Supporting activities that discharge low levels of contaminants and/or demonstrate a commitment to reducing contaminant discharges;
- Requirement for properties with an area greater than 2 hectares (excluding urban properties) to be registered with council;
- The application of farm environment plans for farming activities requiring consent or registered to a Certified Industry Scheme.
- Stock exclusion from water bodies;
- Establishment and operation of a publicly available accounting system and monitoring in each Freshwater Management Unit.
- 8. Under the proposed stock exclusion provisions, ARPHS notes that farmers within priority 1 sub-catchments could effectively have until 2023 to exclude stock from water bodies. ARPHS considers that farming activities should be required to fence off water bodies much sooner, especially in light of the recent release of the 'Clean Water Package 2017¹' consultation document, which is proposing stock exclusion from waterways for some forms of farm stock as earlier as 1 July 2017.


