MY SUBMISSION IS THAT

The Central Waikato Catchment Committee supports the Healthy Rivers initiative but seeks to have Karapiro Catchment changed from a Priority 3 to Priority 1 catchment on the basis of its ongoing high sediment load and contribution to suspended sediment and discolouration of the Waikato River at Cambridge. The soils, topography and current land uses determine the high potential for high sediment yield during storm events and mitigation measures are urgently needed to reduce the sediment yield.

The Central Zone is one of eight management zones in the Waikato Region that provide the basis for the Regional Councils integrated catchment management programmes. The appointed Central Zone Committee comprises representatives from the Waikato Regional Council Councillors, key agencies, community representative and property owners. The Central Zone committee members have an interest in catchment management and outcomes, ensuring provision of effective services for communities in the zone.

A key component of work directed by the Zone Committee is catchment management activities, in particular in the Karapiro Catchment (Catchment 32, Map 3.11-2). The Karapiro Stream catchment is one of the main contributors to sediment in the Central Waikato Zone due to stream bank and sheet erosion. The catchment is the Central Zone's highest priority for focussing works including stock exclusion, bank stabilisation, land and riparian management. These activities have been undertaken in this catchment for a number of years but have yet to be sufficiently advanced to reduce entrainment of sediment in the stream flow significantly. In addition, localised storms in the catchment in recent years have accelerated erosion by creating localised damage to pasture and stream banks that has increased sediment into the stream. The Karapiro catchment is also shown as a high priority for erosion/sediment loss in the Regional Prioritisation maps.

As a result of the investment to date and the importance of controlling sediment in the catchment, and reflecting the on-going susceptibility to erosion, the Central Zone Committee seeks to change the catchment from a Priority 3 to a Priority 1 Catchment. This will ensure that the importance of work already completed and underway by landowners is recognised and that the council actions and expenditure will ensure erosion mitigation continues as fast as possible. The existing relationships with landowners in the catchment will assist Waikato Regional Council in implementing Farm Environment Plans and resultant initiatives that Healthy Rivers promotes.
