They strike a balance between the different aspects of sustainability, in acknowledging the importance of restoration of the rivers' ecological health, which must be of paramount focus, but also the impact that restoration can have on social, cultural and economic factors. It is well overdue to address the failings of our current water management systems and to put in place a more durable, long-term strategy that recognises all the key impacts on these rivers. We must move away from a development at all costs mentality that has degraded our rivers. We must recognise the real costs of this degradation and ascribe at least some of this cost to those who degrade the river. I recognise this strategy represents a shift in the way we do business and that this could impact on the livelihoods of some of those who depend on the river or the lands that feed into it in various ways. However, it is not justifiable to ignore the benefits that some of these users accrue whilst the rest of the population bears the cost. I believe that the timeframe specified in the plan is reasonable for all parties affected, although change for ecological outcomes would be preferably quicker. i recognise that we must all work together and create fair and equitable systems for change, so that we support those to make change who most need to undertake it. There is no alternative to change, and those who resist it should have their motives severely tested.
