Firstly, I am grateful for the work that has been put in to creating this proposed plan change to improve water quality in the Waikato and Waipa catchments. I am also grateful for the opportunity to make a submission. I have read the contents of the proposed plan change, and broadly support the stated objectives, policies and rules. I am pleased that tangible progress is being made toward cleaner rivers in our region. With regard to the target water quality criteria, US EPA recommendations for E. coli counts include an average value, as well as a 90th percentile value, yet only a 95th percentile target value is specified in Table 3.11-1. Furthermore, the maximum 95th percentile target value of 540 cfu/100 mL seems high compared with the alert criteria specified in Section E.5 from Part II of the 'Microbiological water quality guidelines for marine and freshwater recreational areas' published by the the Ministry for the Environment. I do understand that the 540 cfu/100 mL value is taken from the National Policy Statement for Freshwater Management 2014. I submit that an average value target for E. coli based on contact recreation be included unless there is a scientific consensus against doing so. Secondly I submit that the target 95th percentile E. coli counts be revised downward to be in line with the MfE recommended 'Surveillance' or 'Alert' levels unless there is a scientific consensus against doing so. Notwithstanding the above, I submit that the proposed Plan Change 1 be adopted by the Council.
