## Introduction

My husband Ross and I are at present in the process of purchasing our neighbours property which will give us just under 20ha – the property will be made up of 4.7850ha which we have farmed for 13 years and 15.6600ha which our neighbours have farmed for approximately 20 years. Our farm is on the north side of Te Kuiti and In the Priority 1 catchment (Mangapu sub catchment).

We have farmed sheep on our property and the neighbours sheep and beef. Once amalgamation of titles is complete we intend to continue to run sheep and beef, improving production and grazing patterns. The former owners through lifestyle choice and health constraints were not intensively farming.

Now we have more scope and the ability to farm more intensively we intend to improve production and vary the type of sheep and beef we farm. Re-fencing, contouring and repairing ground are in future plans.

Our original 4ha, has no streams that run all year round. The additional hectares have a running stream and wet area that are already fenced and planted out. We intend to re-fence the area to make it completely stock proof. A gully with native bush and a stream that doesn't run all year will be fenced to exclude cattle.


The proposed plan, especially 3.11.5.2, allows no flexibility and is extremely limiting and doesn't take into account the variables that are farming in New Zealand – markets and weather. It stifles the very thing that New Zealand was built on – innovation and adaptability.

For that reason I seek that the plan in its current form be declined.


