# MY SUBMISSION IS THAT

The upper section of the Waikato River has inadequate access for small boat users. The section between the Fulljames Rapids and Mihi is ideally suited for recreational use. Previous access from the Aratiatia Power Station to the rapids has been closed by the Maori owners. The access via the previous Fletcher Forest reserve off the Broadlands Road has also recently been closed due to a change of ownership of the land. For small boat users who like to move downstream (using only manual power or minimal sized engines) fishermen and suchlike, the area near and below the Fulljames Rapids is now inaccessible. I therefore submit that the existing forestry road leading east off SH5 extending from Tram Road be made a public road. The area is now being or has been cleared of pine forest and is likely to become farmland. There is a low lying area suitable for small boat landing there at or near GPS ref.176;11:28:880-38;36;08:644. It is close to the Fulljames Rapids and would make these again available for kayak users such as the Auckland University kayak club and people such as myself who enjoy just drifting downstream towards Lake Ohakuri.
