Introduction

Thank you for the opportunity to submit on the Waikato Regional Councils proposed Plan Change 1.

We are sheep and beef farmers, farming in the Aria district; west coast zone.

Our stock ratio fluctuates with each season and can vary from 48% sheep:52% cattle in late winter/spring to 62% sheep: 38% cattle in summer. My family have been farming in Aria for close on three decades. We are constantly maintaining and upgrading our infrastructure such as water systems, tracks and fences. Our future aspiration is to plant more trees and fence off waterways where this is sensibly and logically viable and done over an extended period of time (*with hopefully some government assistance*) so our farming business can afford such an exorbitant expense.
