Although we are in support of stock exclusion from major waterways and believe that progressively and in principal the plan should include this, we are concerned about the extent of waterways included and the individual farming business's bearing the cost of fencing off and maintaining riparian strips. For example we have a lot of small creeks and guts on our property that could not feasibly be fenced off due to A) cost, B) stock/pasture management, C)terrain making fencing near impossible in some areas Another problem with fencing off waterways is weed control within the riparian strip - in our case the main problem would be small waterways becoming choked with blackberry -what do we do -spray chemicals that close to the water?? Personally I would rather have a wee bit of oc woung breaking down in the water than brushkiller(that doesn't break down)!! We can also envisage calverts becoming blocked by weed build up -potentially causing flooding and erosion, also fences in low ares will lose height as the debris builds up against it, creating a maintenance nightmare.
We seek that the provision is amended as follows: *That more research is done on the effects of stock exclusion of the more minor waterways
*That farm fencing of water bodies is tailored to that farms own environment plan, with consideration given to the impact on stock /pasture management and cost to business *That alternatives such as pond systems are investigated
That allowalities soon as point systems are invoctigated
