The reasons for this are:

* Fencing off all waterways and wetlands would have a negative environmental impact due to tracks As an alternative I having to be buildozed on the sides of Hills for fencing which will create more erosian and sediment into the waterways.

* This farm has more than 15 km of waterways and swamps running through it and the cost of fencing off will be finacially viable.

*Fenced off waterways would become over run with blackberry and Tutsan which would require heavy application, of chemical to control which would be harmful for water quality. This is already a problem on the banks of the Awakino river which we fenced off 10 years ago.

SUBMISSION POINTS: General Comments

I am in a family partnership on a 377 ha dry stock farm in Mahoenui, wintering 10.5 stock units per hectare. 70% sheep, 30% cattle. I have both breeding stock and finishing stock on my property.

The farm is located in the west coast catchment on the Awakino River. The farm has been in our family for 70 years and has always been an economical unit.

I have always been aware that we are all caretakers of the land and as well as make a living we want to leave it a better place for the next generation. Without having unnecessary policies and rules to guide me I have made the changes and installed an extensive water system so all our paddocks have water troughs, many with more than one and I use electric wires to keep stock from contaminating the waterways and doing damage to the banks. I graze the paddocks with the stock it is suited to so not to cause erosion and wash topsoil into the drains. We have planted hundreds of trees over the years for the benefit of the land and stock. I fertilize the land every year to keep it healthy and productive. This and more has been done over the years with no set timeline but as it is affordable. This year I have spent \$10000 on upgrading crossings to keep stock out of the waterways. I source most of my supplies from the local towns, which are also going to feel the effect of farmer's incomes being redirected into other areas.

In the future I have no real plans for any major changes, but if circumstances change I would like to have that option to be able to change my farming practices.

I am concerned for farming in the future.
