(Please continue on separate sheet(s) if necessary) History has shown through the implementation of specific government legislation, Maori has suffered significant injustice and the eventual confiscation and sale of their lands. This submission objects to the proposed Plan Change on the basis that the Collaborative Stakeholder Group has not recognised the impact this plan will have on multiple-owned Maori freehold lands that cannot generate an income due to its terrain and/or the size of the land to cover the expense of fencing waterways on the property. It can be assumed that such Maori owned lands would not have any stock grazing and/or fertilising of vegetation crops to contaminate the waterways. How are these landowners able to comply with the Plan and would they still be required to fence off the waterways? What is the consequence if the landowners do not comply with the request to fence off waterways? Maori have always revered the life sustaining capabilities of the rivers, lakes and streams, and recognise that the cause of such pollution is a direct result of colonisation and capitalism. However, it has and always will be a concern for Maori that the government accepts the concept of human sewerage entering such an essential resource 'within suitable levels' and yet unable to see how this is contradictory to the very plan put forward by its agency to keep the waterways clean. The solution is simple, stop animals excreting into the waterways, stop the use of nitrate fertilisers and stop all levels of human sewerage entering the waterways. The government needs to force companies to stop manufacturing products that will cause further harm to the environment and the waterways.
