

I oppose this change including the 75th percentile rule. based on two low dairy payout years nitrogen and other fertiliser application has been significantly lower than the norm and this is reflected in our nitrogen base point. Measurement and monitoring for a period of 5 -10 years would more accurately reflect long term nitrogen use.

I object strongly to the disclosure of private financial information. What purpose does this serve.

No opportunity has been available to submit on this rule implemented on 22nd October 2016. This unfairly restricts future land uses, which creates land value equity loss.

Farmers are further financially burdened by the requirment to have a Farm Environment Plan prepared by a Certified person. The robust Third Party Audit (independent of the farmer and Certified Farm Environment Planner) will be an addition cost to the farmer. The compliance required to farm requires greater input than the actual physical farming.

All farmers should be treated equally, no provision for Tangata Whenua should be granted.

No part of the property or enterprise over 15 degrees slope is cultivate or grazed. This rule is unrealistic and will have serious negative impacts of farming in New Zealand and the economy of New Zealand.

I support the concept of Health Rivers, but this responsibility should not be shouldered by farmers alone. The Waikato Regional Plan Change 1 – Waikato and Waipa River Catchment plan does not include any reference to urban dwellers or business. Waste water discharge into the Waikato River, from non-farming activities does occur, why is this not addressed in the plan.

We own a 100ha season supply dairy farm milking 260 cows. A 40ha run-off grazing 120 replacement heifers and some beef animals. We lease a further 30ha, used for winter grazing and to grow grass and maize silage for our dairy farm.

We operate a DairyNz System Two dairy farm, with minimal external feed inputs. Those we do feed are grown on our run-off and lease land consist of grass and maize silage. Our nitrogen reference point for the past two years as per our Fonterra Nitrogen Report is relatively low. This is due to the financial constraints of a low dairy payout for the last two year.

We have undertaken the following environment projects in the last 5 - 10 years and consider that we farm to mitigate environment impact:

- Fencing of drains to exclude livestock, approximately cost \$15,000
- Upgrading our effluent system with the construction of a new plastic lined pond, approximately \$100,000. Installation of a new sump and pump. This supports our land based system.
- Tree plant
- Stand cows off the pasture in very wet weather to minimise soil erosion.
- Once-a-day milking –

We have no immediate plans to expand our current arming operation by either increasing stock rate or changing our farming system, but do not want to be restricted by the constraints of the Health Rivers Plan. I intend to further extend our land based effluent spreading systems to provide a large area to disperse the effluent.

I support the submission that has been lodged by Federated Farmers. I am particularly concerned about the following aspects of Plan Change 1:

- The significant negative effect on rural communities
- The cost and practicality of the rules.
- The effect that the Nitrogen Reference Point will have on my business and my economic wellbeing.
- The Farm Environment plan requirements leading to unnecessary and costly regulation of inputs, outputs, normal farming activity and business information
- The costs and practicality of the rules and requirements for stock exclusion, the Nitrogen Reference Point and the Farm Environment Plan.
- The timeframes for complying with the Nitrogen Reference Point rules which are too short and unachievable
- The plan significantly exceeding the 10 year targets in many attributes and areas
- The lack of science and monitoring at the sub catchments level
