- 1. Oppose rule 1
- a. The rule grand parents forestry land use. By grand parenting forestry the plan change will actively discourage new plantings of forests. This is despite the economic model indicating that increased areas of forestry would greatly assist in meeting the requirements of the vision and strategy for the Waikato.
- b. The rule is inequitable as there is no limitation on increased intensification of an existing land use up to the maximum impact achieved on a property between the years 2014-15 and 2015-16.
- c. Constraint on land use change will constrain investment in forestry and reduce forestry land values and perversely provide no incentive to plant more forests.

Support in part. The proposed NES for plantation forestry also has a requirement to notify the territorial authority prior to harvest commencement. Requirements for harvest plan map content (part a) are supported. Re part b: Best practice sediment and slash management controls are supported, as is an overarching plan to manage sediment and slash for a forest area. Detailed block by block sediment and slash management plans although required, need to have the flexibility to be modified as operations progress to ensure the best environmental outcome. Past experience has found that sub optimal outcomes for sediment and slash management have resulted when the forest manager has been required to adhere to a rigid slash and sediment plan for a harvesting block that has been prepared too far in advance of operation commencement. During harvesting, operational or localized environmental requirements often result in a need to change the plan to achieve a better environmental outcome. Forest owners have in the past been penalised by regulators for not adhering to the plan detail even though the outcomes from plan changes were more environmentally favourable.
