Proposed principles around information provision

- 1) Provide all information that CSG has had access to (at an agreed point in time)
- 2) Provision of both economic modelling and integrated assessment (they go together)
- 3) Expert assistance at meetings to explain modelling and integrated assessment (if required)
- 4) Provide information to sectors and community at the same time <u>or</u> provide information to sectors in confidence first then community?
- 5) Have clear and agreed messages that are signed off by CSG
- 6) Focus of engagement is on the policy options as opposed to the modelling detail
