## 1 Purpose

The purpose of this report is to provide the Collaborative Stakeholder Group (CSG) with information on the large point source discharge consents in the Waikato and Waipa catchments.

## **Recommendation:**

## 2 Large point source discharge consents

At workshop 17 CSG requested information on the main point source discharges in the Waikato and Waipa River catchments, specifically their expiry date and any review clauses. Below is a table outlining this information.

Points to remember:

- What is consented and what is actually discharged can be quite different
- Older consents were written for a 'worst case scenario' to manage during wet times or possible factory malfunctions, rather than a usual day to day discharge eg 'concentration should not exceed X'
- Information about what is actually discharged was presented to CSG at workshop 5, 14-15 August 2015.<sup>1</sup>
